Subject: Allocation of trainees under Upgrading the Skills and Training in Traditional Arts/Crafts for Development (USTTAD) for the year 2018-19.

Sir,

I am directed to say that based on meeting before the Inter-Ministerial Screening Committee under **Upgrading the Skills and Training in Traditional Arts/Crafts for Development (USTTAD)**, a scheme of the Ministry of Minority Affairs, **the organizations (list enclosed) have been provisionally selected as a Project Implementing Agencies (PIAs) under the scheme for the year 2018-19 & 2019-20. Further, the Ministry has approved fresh tentative allocation of 90 numbers of minority trainees to be trained by the PIA under "USTTAD" during 2018-19. The allocation of trainees made can vary based on the art/crafts being proposed by the organization.**

2. In view of the allocation of trainee the PIA is required to submit proposed centre/centres of training and the details of art/craft to be trained alongwith duration both number of hours and total moths as per prescribed formats given in **Annexure – I to V latest by 24.12.2018**. The preference would be given to those trades which are languishing and practiced by Minorities in India. The course duration and curriculum would be as per as per para 4 of the guidelines.

3. The organization shall focus on training of youth in identified clusters with the help of Master Craftsman/Artisans. The organization shall focus on all minority communities namely i.e. Muslims, Christians, Sikhs, Buddhists, Parsis and Jains. They shall also earmarked minimum 33% for minority girls/women as per guidelines of the scheme. Guidelines of the schemes are available on the website i.e. www.minorityaffairs.gov.in of the Ministry.

4. The PIA will register itself on NGO Darpan Portal of NITI Aayog and provide unique id number to the Ministry alongwith the screenshot immediately. It is mandatory before release of funds.

5. The allocation is purely provisional and subject to scrutiny and verification of documents submitted by the PIA.

6. The trades submitted by the PIAs would be finalized only after consulation with the knowledge partners of USTTAD i.e. National Institute of Design (NID) and National Institute of Fashion Technology (NIFT). The sanction order would we issued after finalization of the trade.

7. An undertaking is to be submitted by the PIAs for blacklisting of the organisation as per annexure annexed.

8. The sanction order/allocation order is being issued based on the credentials submitted by you in the application forms. Any discrepancies would be found would entail the cancellation of the allocation letter.

9. **It is requested to furnish the details in the prescribed format as requested at para 2 above.**
